

PROCESS FOR BEAVER TAIL REQUEST FORM

1. The Landowner completes the **BEAVER AUTHORIZATION & CERTIFICATION REQUEST FOR PAYMENT FORM; [section 1](#)**.
2. The Trapper must be a permanent resident of Grey County or apply for a non-residency exemption. This is done by requesting permission to trap in Grey County via a letter that is then presented to the County of Grey; Planning and Community Development Committee for approval/denial.
3. The Trapper contacts the Municipality of Meaford; Operations Department located at 157859 7th Line, Meaford, ON for certification. Please call (519) 538-1060 ext.1315 to book a time to drop off tails. The trapper presents the beaver tails and the ends are notched or removed.
4. The designated Municipal Staff will sign the form verifying the trapper and number of beaver tails presented. The form will be forwarded to the Municipal Office for signature from the Clerk and completing **BEAVER AUTHORIZATION & CERTIFICATION REQUEST FOR PAYMENT FORM; [section 2](#)**.
5. Municipal Office will forward form for payment to County of Grey, 595 Ninth Avenue East, Owen Sound, ON, N4K 3E3 completing **BEAVER AUTHORIZATION & CERTIFICATION REQUEST FOR PAYMENT FORM; [section 3](#)**.
