I acknowledge that the \$1,500.00 Security Deposit can be used by the Municipality to rectify any damages to any Municipal right-of-way or Municipal property if same has not been rectified by the Owner following the provision of notice to the Owner by way of prepaid registered mail to the Owner's address noted on the permit application.

I acknowledge that in the event a permit is issued, any departure from specific conditions, plan, specifications or building locations proposed in the above application is prohibited and such could result in this permit or, if applicable, the building permit being revoked.

I further acknowledge that in the event that the permit is revoked for any cause or irregularity or non-conformity with the by-laws or requirements of the municipality or the *Building Code Act*, 1992, or regulations made thereunder, there shall be no right of claim whatsoever against the municipal corporation or any official, employee or agent thereof and any such claim is hereby expressly waived.
