Recommendation

Executive Summary

In accordance with Section 284 of the Municipal Act the Municipality is to provide the annual remuneration for Council. This report provides the 2022 amounts for members of Council in advance of the March 31, 2023 deadline.

Background

Section 284 of the Municipal Act requires that on or before March 31st, the Treasurer shall provide to the Council of the Municipality an itemized statement on remuneration and expenses paid in the previous year to each member of Council in respect of his or her services as a member of Council or any other body, including a local board.

Further, the Treasurer is required to include each person appointed by the Municipality to serve as a member of any body, including local boards.

Salary and expenses for Mayor and Council are paid in accordance with By-Law 2021-86 dated November 29, 2021. The figures below include all payments between January 1, 2022 and December 31, 2022.
